Guidance for Organisations

Awards Process

The JMA Trust is a small charity. The typical size of an award to an individual falls between £100-£1000. For groups/organisations, the typical size of an award is £200-£2000, and is unlikely to exceed £3000. Awards to D & G schools and sports clubs/groups are limited to £1000.

The JMA Trust meets four times per year to consider applications. Deadlines for applications throughout the year can be found on the Trust's website and social media channels. We will aim to inform applicants whether or not they have been successful within 1 month of each deadline. All decisions of the Trust's awards committee are final.

The application form is your chance to tell us about yourself and how an award from the Trust would make a difference to your life. Please try and answer each question as openly and honestly as you can.
